Dear Parent/Guardian:

Whooping cough (pertussis) has been widespread in California. Many students have had to miss school because they were sick.

To help protect your children and others from whooping cough, a new California law now requires students to have a booster shot against whooping cough.

For the 2011-12 school year only, all students entering 7th through 12th grades will need proof of an adolescent whooping cough booster shot (Tdap) before starting school.

Thereafter, in future school years, only students entering 7th grade will need proof of an adolescent whooping cough booster shot (Tdap) before starting school.

By law, students who do not have proof of receiving a Tdap booster shot will not be able to start school until proof is provided to the school. (The tetanus-diphtheria booster shot, Td, will not meet the requirement.)

To insure your student starts school on time:

- 1. If your student has already received a Tdap shot on or after their 7th birthday:**
Provide your student's school nurse with a copy of their immunization record **NOW**.
- 2. Get your child's Tdap shot NOW if they have not already received it.**
A large number of students need a Tdap shot between now and the start of school next year. Make an appointment with your child's doctor or clinic for your student to get a Tdap booster shot **NOW**. Avoid the back-to-school rush. Provide your student's school nurse with a copy of the immunization record as soon as possible. For you and your healthcare provider's convenience, take the attached "Healthcare Provider Verification" form with you to the appointment. Once completely filled out, return the form to your school nurse.

Getting the adolescent whooping cough shot **NOW** will not only help protect your student against the ongoing threat of whooping cough but will also meet the new school requirement.
