About This School

Pioneer Elementary is a K-6 school set amid a forest of pine, cedar, and madrone trees at the 3200 ft. elevation on the western slope of the majestic Sierra Nevada mountain range with approximately 220 students. The school is the oldest continuously operated school in the District, built in 1944 to house a K-8 population.

Pioneer now consists of 11 classrooms, a full stage and auditorium, a library and a computer lab for 32, and a beautiful children's discovery garden. We also have a special education class and preschool. We offer a site funded Physical Education program as well as art and music sessions throughout the year.

We are proud of our strong relationships with our community and parents.. Parent volunteers are a very important part of the success of our school, as is the dedicated staff, which focuses on California State Standards while making learning an adventure by involving students in drama, visits to the nearby national forests, field trips and school assemblies. A variety of Response-To-Intervention programs are utilized at our site for those students that need extra help.

There is a continuing effort on the part of the staff and parents to improve teaching and learning at Pioneer Elementary School. Site staff is professional and cohesive in its collaborative approach to planning and refining new and existing curriculum. We believe in facilitating academic and extra curricular programs that allow all children to reach their full potential. Teachers participate in district provided professional development which allows them to keep current on best practices in education.

Extra curricular classes are taught by our staff that provide clinics for students struggling in math and reading or that provide enrichment opportunities like Yoga and Drama.

The community at large is very involved in our school and we have a direct partnership with the Bank of Amador and Payless/IGA Market. Those two local businesses support and participate in an annual golf tournament that raises funds for our school. The local Lyons Club and the Up Country Rotary provide special events at our site including a Geography Bee and a Books for Bikes event.

IX. Student Performance

Standardized Testing and Reporting Program

The Standardized Testing and Reporting (STAR) Program consists of several key components, including the California Standards Tests (CSTs); the California Modified Assessment (CMA), and the California Alternate Performance Assessment (CAPA). The assessments under the STAR program show how well students are doing in relation to the state content standards. The CSTs include English-language arts (ELA) and mathematics in grades two through eleven; science in grades five, eight, and nine through eleven; and history-social science in grades eight, and nine through eleven. The CAPA includes ELA and mathematics in grades two through eleven, and science for grades five, eight, and ten. The CAPA is given to those students with significant cognitive disabilities whose disabilities prevent them from taking either the CSTs with accommodations or modifications or the CMA with accommodations. The CMA is an alternate assessment that is based on modified achievement standards in ELA for grades three through nine, mathematics for grades three through seven and Algebra I and science in grades five, eight, and ten. The CMA is designed to assess those students whose disabilities preclude them from achieving grade-level proficiency on an assessment of the California content standards with or without accommodations. On each of these assessments, student scores are reported as performance levels.
